Speaker Biographies

THOMAS N. N. ANGELL, ESQ., graduated from Hofstra Law School in 1981 with honors. That same year, the national Legal Services Corporation selected him as a Reginald Heber Smith Fellow. Mr. Angell was assigned to work at Mid-Hudson Legal Services, Inc., where he remained as a staff attorney at the expiration of his fellowship. In 1989, he was appointed a Senior Assistant Public Defender in Dutchess County. In 1995, the New York State Bar Association awarded Mr. Angell the Dennison Ray Criminal Division Staff Award for Indigent Representation. He was appointed Chief Assistant Public Defender in Dutchess County in 2004. In 2013, Mr. Angell became Dutchess County's fifth Public Defender.

HOLLY K. AUSTIN, ESQ., is a partner in the Environmental Practice at Hancock Estabrook, LLP. She focuses on all aspects of environmental law, including permitting, state and federal environmental, health and safety regulatory compliance and enforcement, remediation, zoning, and land use. Ms. Austin has negotiated enforcement and permitting issues with the New York State Department of Environmental Conservation; United States Environmental Protection Agency; United States Army Corps of Engineers; Public Service Commission; New York State Department of Health, Occupational Safety and Health Administration; and New York State Department of Labor. She served as the pro se law clerk for the Federal District Court for the Northern District of New York, under the supervision of the Hon. Gustave J. DiBianco, from November 2004 through May 2005. Ms. Austin is a Member of the Onondaga County Bar Association; the New York State Bar Association; Onondaga County Volunteer Lawyers Project; Syracuse City Court Small Claims Arbitration Program; Central New York Women's Bar Association; and Mid-Atlantic States Section of the Air & Waste Management Association's Board of Directors. She is President of the Matilda Joslyn Gage Foundation's Board of Directors; Past Chair of the Central New York Air & Waste Management Association's Board of Directors; and Past President of the Friends of Historic Onondaga Lake Park, Inc.'s Board of Directors. Ms. Austin received a BA, cum laude, from Colby College and a JD from Cornell Law School. She is admitted in New York and the United States District Court for the Northern District of New York.

ANDREW AYERS, ESQ., graduated first in his class from Georgetown Law in 2005. He then clerked for the Honorable Sonia Sotomayor, now a US Supreme Court Justice, during her term on the US Court of Appeals for the Second Circuit. He also clerked for the Honorable Gerard Lynch on the US District Court for the Southern District of New York. After clerking, Mr. Ayers worked for nine years in the office of the New York Attorney General, where he was a Senior Assistant Solicitor General. He served both as a supervisor and as lead counsel in various high-profile cases involving immigration law, states' rights, constitutional rights, environmental law, and other issues. Since November 2016, Mr. Ayers has served as Director of the Government Law Center and Visiting Assistant Professor at Albany Law School. He is the author of *A Student's Guide to Law School*, published by the University of Chicago Press, as well as three articles on legal ethics and an article on immigration law.

JONATHAN M. BERNSTEIN, ESQ., is a partner in the Albany, N.Y., law firm of Goldberg Segalla. He concentrates his practice in municipal liability, general litigation, professional liability, appellate advocacy, and defending civil rights and employment discriminations suits. Mr. Bernstein has defended government agencies, elected officials, police officers, corrections officers, as well as numerous counties and local governments in civil rights suits in federal and state courts. His professional liability experience includes representing accountants and lawyers in malpractice lawsuits. Mr. Bernstein has handled appeals before New York's appellate courts, including the New York Court of Appeals and the United States Court of Appeals for the Second Circuit. He has also tried cases to verdict in state and federal court. Mr. Bernstein was a confidential clerk for the New York Court of Appeals from 2002-2004. He serves as editor of Goldberg Segalla's Government Liability, Civil Rights and Labor and Employment newsletter and as a Court Reporter Correspondent for the Defense Research Institute's Government Liability Committee. He is admitted to practice in New York; the US District Courts for the Northern, Western, and Southern Districts of New York; US Court of Appeals for the Second Circuit; and the US Supreme Court. Mr. Bernstein is a member of the Town of Sand Lake Planning Board. He received a BA from the University of Colorado at Boulder and a JD, cum laude, from Brooklyn Law School, where he was Assistant Managing Editor of the Brooklyn Law Review. Mr. Bernstein is the author of numerous articles.

VICTOR A. CIVITILLO, ESQ., is a Senior Assistant County Attorney in the Dutchess County Attorney's Office. Mr. Civitillo has been prosecuting juvenile delinquency and Persons In Need of Supervision (PINS) cases since starting at the County Attorney's Office in 1992. He also handles a variety of other legal matters for the Office. Mr. Civitillo conducts training for police officers in Dutchess County, including school resource officers. He has been teaching both the basic and advanced classes for the

State of New York Police Juvenile Officers' Association for at least the past fifteen years. He has conducted CLE classes for the County Attorneys' Association of the State of New York, the Dutchess County Bar Association, and the Office of Court Administration. He is the author of the original PINS chapter in the *LexisNexis Answer Guide of New York Family Court Proceedings*. Mr. Civitillo is a graduate of Albany Law School and the State University of New York at Albany.

HON. MICHAEL V. COCCOMA is a New York State Supreme Court Justice in the 6th Judicial District. He was appointed Deputy Chief Administrative Judge for Courts Outside New York City in May 2009 by the Chief Administrative Judge. In his position, Judge Coccoma is responsible for managing the Courts in the 57 counties outside of New York City, which includes more than 700 justices and more than 5,500 non-judicial employees. Judge Coccoma was also appointed Supervising Statewide Administrative Judge for Fiduciary Matters by Judge Jonathan Lippman in 2015. He is currently heading a statewide commission to examine procedures and protocol related to courtappointed fiduciaries and is charged with making recommendations to the Chief Judge to improve existing processes. In this role as Administrative Judge for Fiduciary Matters. Judge Coccoma is also overseeing implementation, monitoring, and refinement of these recommendations aimed at improving compliance with Part 36 of the Rules of the Chief Judge. Judge Coccoma is a graduate of The Citadel and earned a JD at Albany Law School. He began his career in private practice and served as Otsego County Attorney. He was elected as District Attorney in 1991. He was elected to his first term as a multibench judge of County Court, Family Court, and Surrogate's Court in Otsego County in 1994. In 2004, he was re-elected to County Court. Judge Coccoma was appointed an Acting Supreme Court Justice in 2000 and elected to the Supreme Court in 2008. He also served as a Drug Treatment Court Judge for seven years. Currently, he presides over felony jury trials in Supreme Court, in Schenectady County, NY, and Supreme Court Civil calendar in Otsego County, NY, in addition to his administrative duties.

LINDA D. FAKHOURY, ESQ., is a Senior Assistant County Attorney for Dutchess County, where she has worked since 2005. Her primary responsibilities include prosecution of juvenile delinquency and persons on need of supervision (PINS) cases, as well as handling contracts, municipal issues, and a variety of other legal matters for the County. Ms. Fakhoury played a vital role in creating the Juvenile Fire-Setters Intervention Response and Education (JFIRE) initiative for Dutchess County, and continues to serve on the Steering Committee and the Full Committee for that program. In addition, she is trained as an Intervention Specialist through the National Fire Academy to address juvenile fire-setting behaviors in the County. Ms. Fakhoury has been an Adjunct Instructor at Marist College since 2011, teaching Criminal Law as part of the Paralegal Certification program. She is an active member of her community and

volunteers for the Junior League of Poughkeepsie and other organizations. Ms. Fakhoury graduated from Marist College in 2001 with a BS in Criminal Justice and a Paralegal Certification. She received a JD in 2004 from Western New England University School of Law, and serves on the Alumni Board of Directors.

ROBERT H. FELLER, ESQ., is Senior Counsel at Bond Schoeneck & King, in Albany, NY. His principal areas of experience include water pollution; SEQRA and environmental impact review; real estate development, including the remediation and redevelopment of brownfields; and municipal law. Mr. Feller has experience in the field of stormwater pollution, having drafted the manual for local financing of the new Municipal Separate Storm Sewer System (MS4) program. He represents three county sewer districts and has addressed a variety of issues related to wet weather flows. Mr. Feller handles cases concerning hazardous substances and petroleum spills, both in the context of enforcement and of contaminated property redevelopment. That practice includes litigation under both state and federal courts. Mr. Feller is the author of the firm's Planning and Zoning Case Law Quarterly Update, as well as the Annual Review. He represents and appears before planning and zoning boards, the DEC, and other state agencies on real estate development matters. Mr. Feller's practice includes representation in administrative hearings, as well as judicial review in the context of Article 78 proceedings. He has counseled municipalities on a number of governance issues, including the adoption of inter-municipal agreements and the formation of special districts. Prior to joining the firm, Mr. Feller served in several capacities at the DEC, including Assistant Commissioner, Assistant Counsel for Energy, and Assistant Counsel for Solid and Hazardous Waste. For more than eight years, he was the sole or principal author of every agency decision issued after an administrative hearing and was the confidential counsel to the Commissioner. Mr. Feller is listed in The Best Lawyers in America® 2017, for the practice areas Environmental Law, Litigation-Environmental, where he has been recognized for 10 years. He has been awarded the AV Preeminent rating by Martindale-Hubbell®, and was selected as a 2013 Top Rated Lawyer in Land Use and Zoning by that law directory. Since 1995, Mr. Feller has been a member of the Executive Committee and Chair of the Environmental Business Transactions Committee for the Environmental Law Section of the New York State Bar Association. He received a BS from Union College, a JD from Albany Law School, and an MBA from Rensselaer Polytechnic Institute.

WILLIAM J. LEAHY, ESQ., attended the University of Notre Dame and Harvard Law School. After practicing for 10 years as a trial and appellate public defender for the Massachusetts Defenders Committee, he became the first Deputy Chief Counsel for the Public Defender Division of the Massachusetts Committee for Public Counsel Services, a position he held from 1984 to 1991. In 1991, he became the second Chief Counsel of

that statewide agency. He served in that capacity until his retirement in July 2010. In February 2011, Mr. Leahy began his tenure as Director of the Office of Indigent Legal Services for New York State, with the mission to improve the quality of representation for poor people in the criminal and family courts throughout the State. His office is currently implementing the landmark settlement between the New York Civil Liberties Union and the State of New York in the right to counsel case of Hurrell-Harring v. The State of New York. From 2002-2011, Mr. Leahy served as an adjunct professor at Brandeis University, teaching courses in American Criminal Law and International Criminal Law and Human Rights. In December 2012, he spoke at the International Conference on Criminal Legal Aid Systems in Beijing, China, where he presented a paper entitled "An Assessment of the Right to Counsel in the United States." On March 15, 2013, he spoke at the US Department of Justice's commemoration of the 50th anniversary of the Gideon decision. His paper, "Amplifying Gideon's Trumpet, Revitalizing Gideon's Rule: A Prescription for Action," was published in the online edition of the University of Louisville Law Review. In April 2014, he gave a keynote address, "The Right to Counsel: An American Perspective and a Global Proposal," at the European Association of American Studies conference in The Hague, Netherlands. In September 2015, Mr. Leahy spoke about "The Role of the Criminal Defense Lawyer" in the United States" at the International Conference on Improving Criminal Justice in Samarkand, Uzbekistan.

ELENA P. PABLO, ESQ., joined Roemer Wallens Gold & Mineaux LLP in September 2013 as a member of the Labor and Employment Group. Her practice focuses on various aspects of public sector labor relations and municipal law, including employee disciplinary proceedings, employment litigation and policy drafting, as well as providing guidance on compliance with state and federal labor, discrimination, and public record disclosure laws. Ms. Pablo also provides employee training on issues including antidiscrimination and harassment, workplace violence, employee corrective action, progressive discipline, and social media. She earned an undergraduate degree in Sociology from Ithaca College in 2007. She graduate from the Maurice A.
